SECTION 4 - FIRST AID MEASURES

Inhalation:

Remove source of contamination or have victim move to fresh air. If not breathing, give artificial respiration. Obtain medical attention immediately.

SECTION 6 - ACCIDENTAL RELEASE MEASURES

Personal precautions:

SECTION 7 - HANDLING AND STORAGE

Safe handling procedures:

Before handling, it is very important that engineering controls are operating, and that protective equipment requirements and personal hygiene measures are being followed. People working with this chemical should be properly trained regarding its hazards and its safe use. Inspect containers for leaks before handling. Label containers appropriately. Ensure proper ventilation. Avoid breathing vapors or mists. Avoid contact with eyes, skin and clothing. Avoid generating high concentrations of vapours or mists. Keep away from incompatible materials such as strong oxidizing materials. Keep containers closed when not in use. Assume that empty containers contain residues which are hazardous.
